

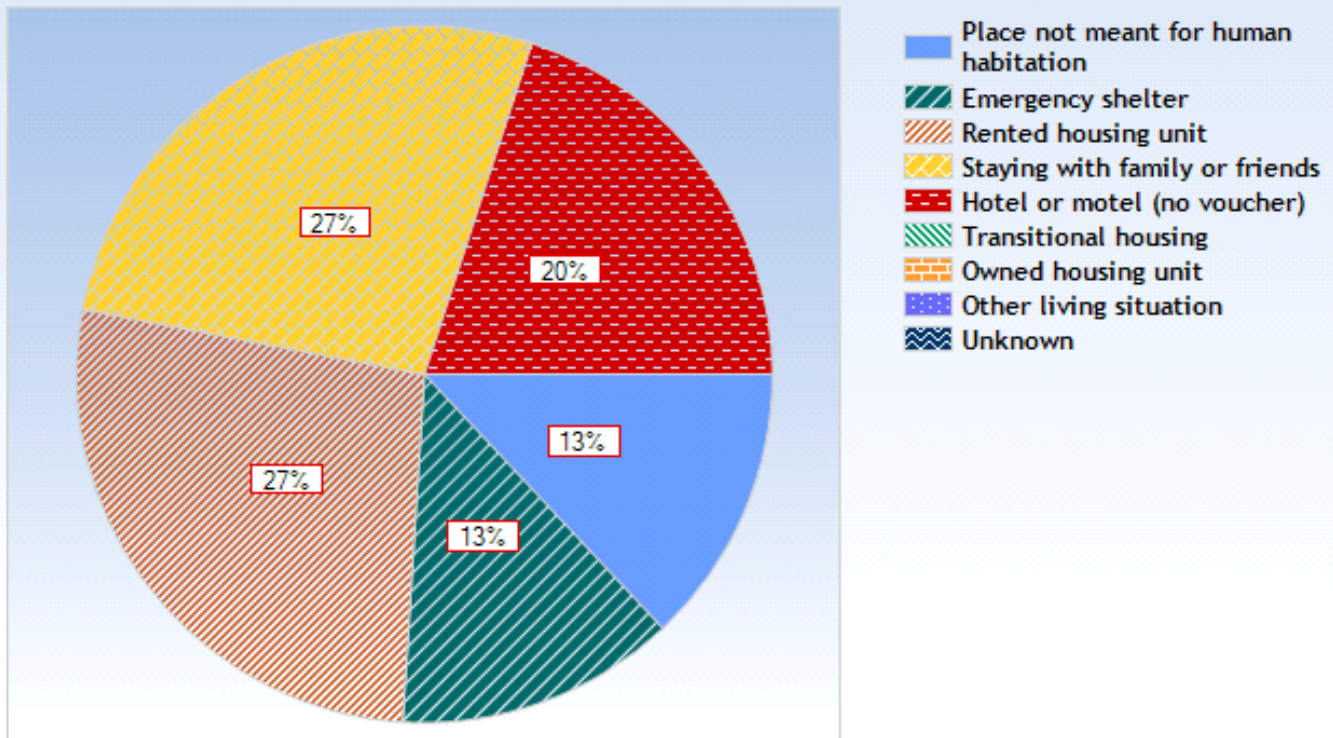

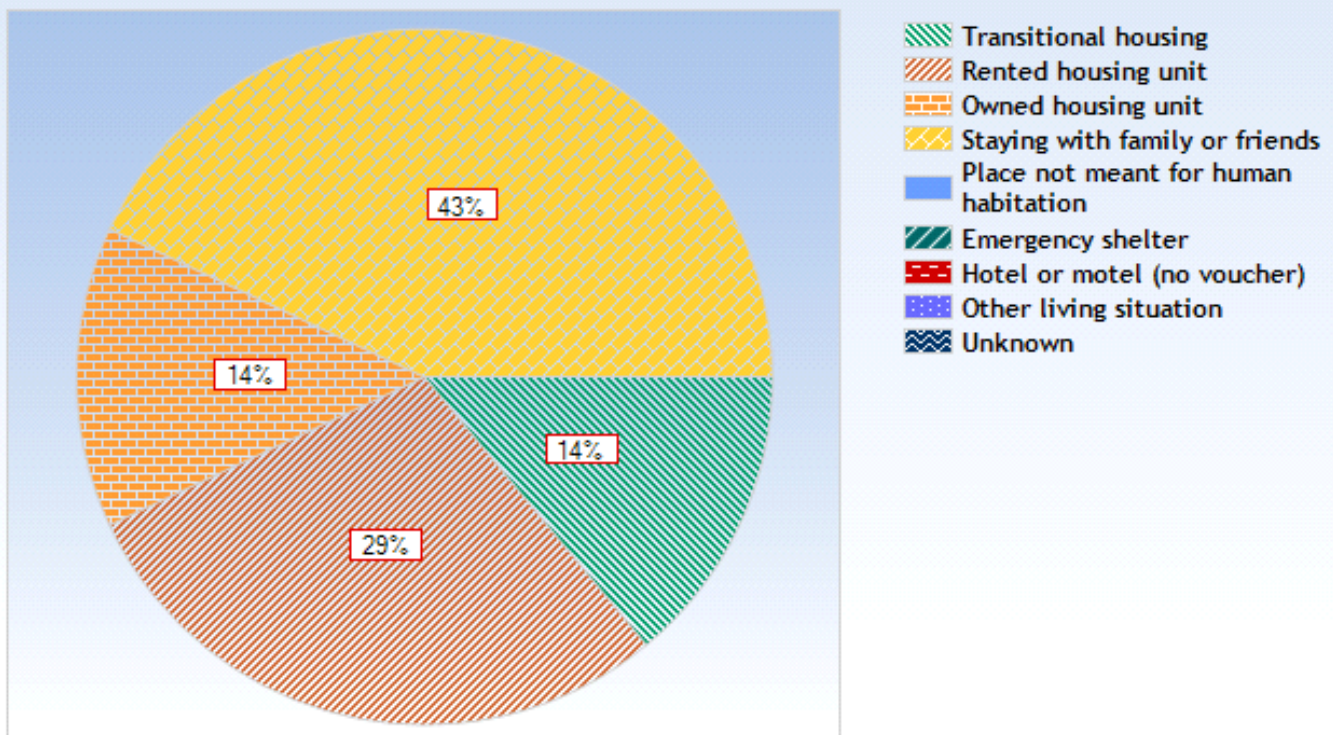

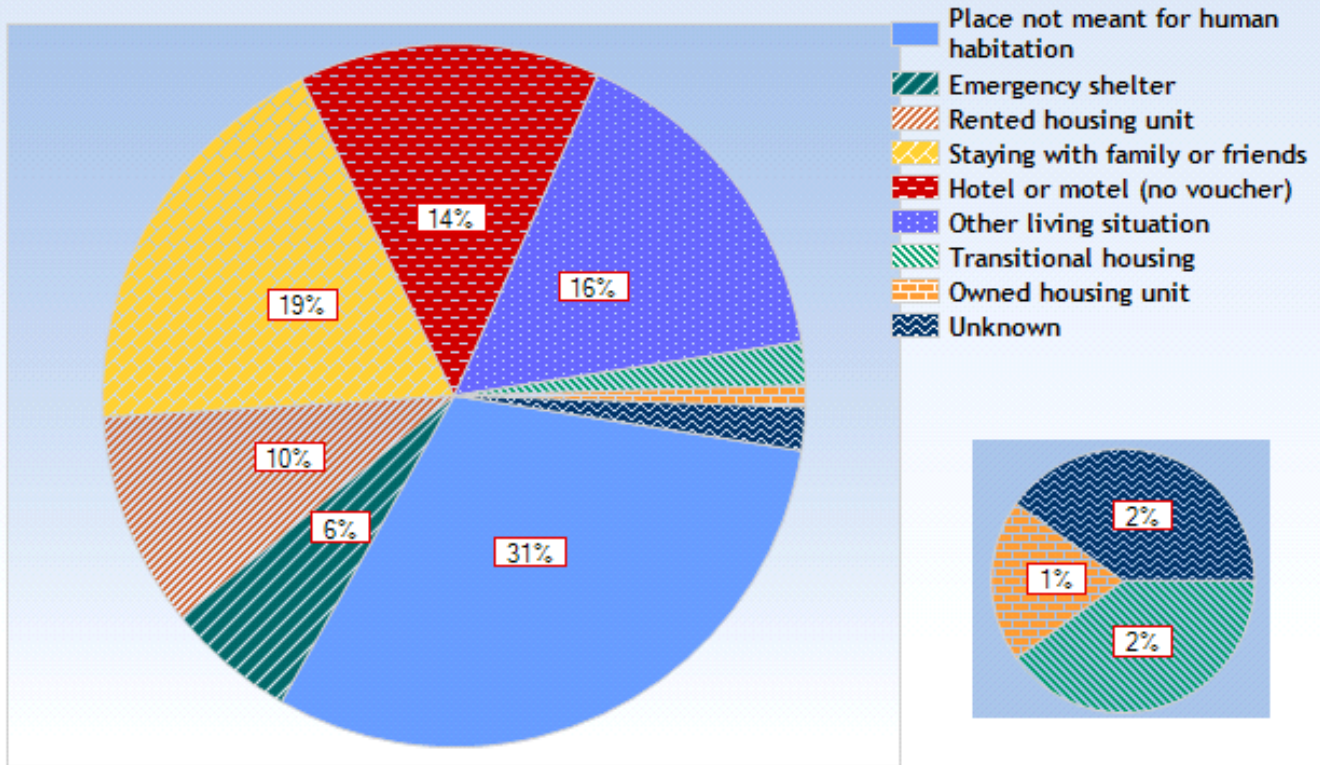
**Exhibit 4.2 Living Arrangement the Night before Program Entry: Veterans in Families in Emergency Shelter**



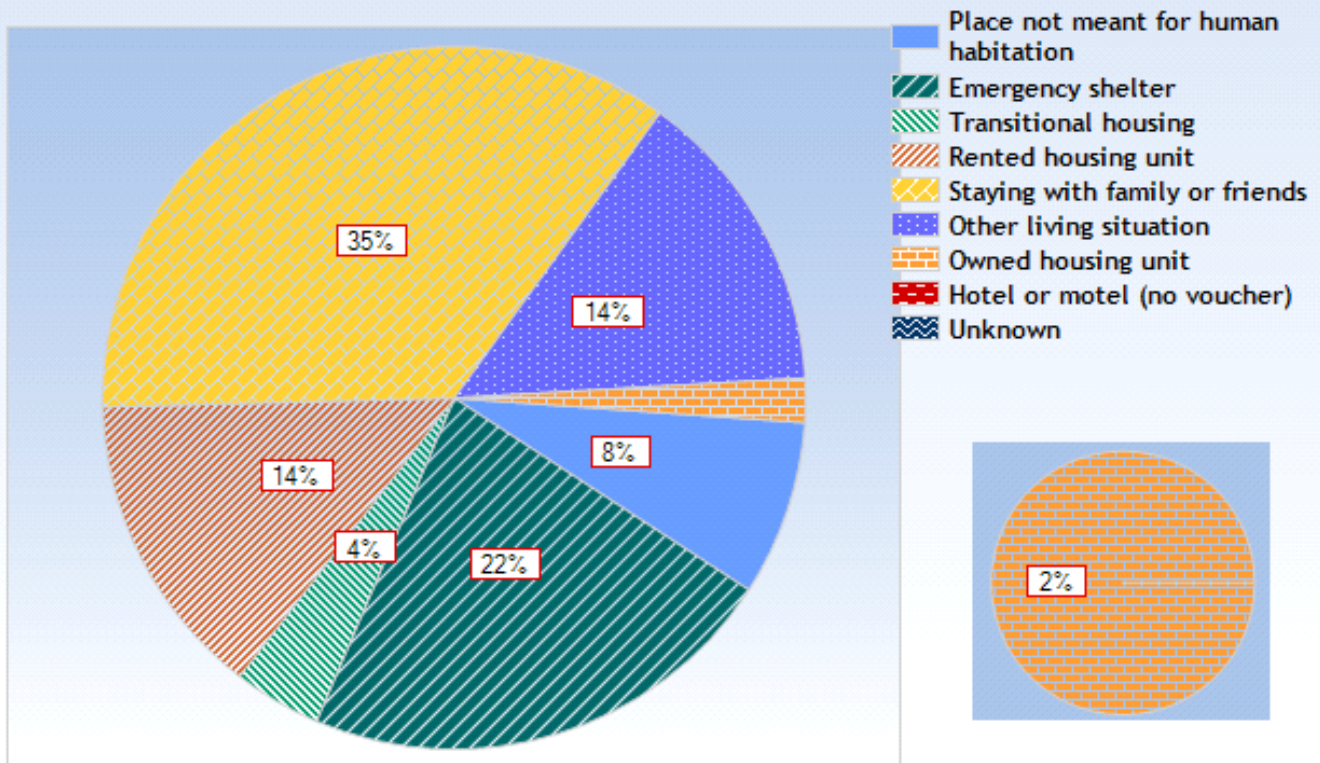
**Exhibit 4.3 Living Arrangement the Night before Program Entry: Veterans in Families in Transitional Housing**



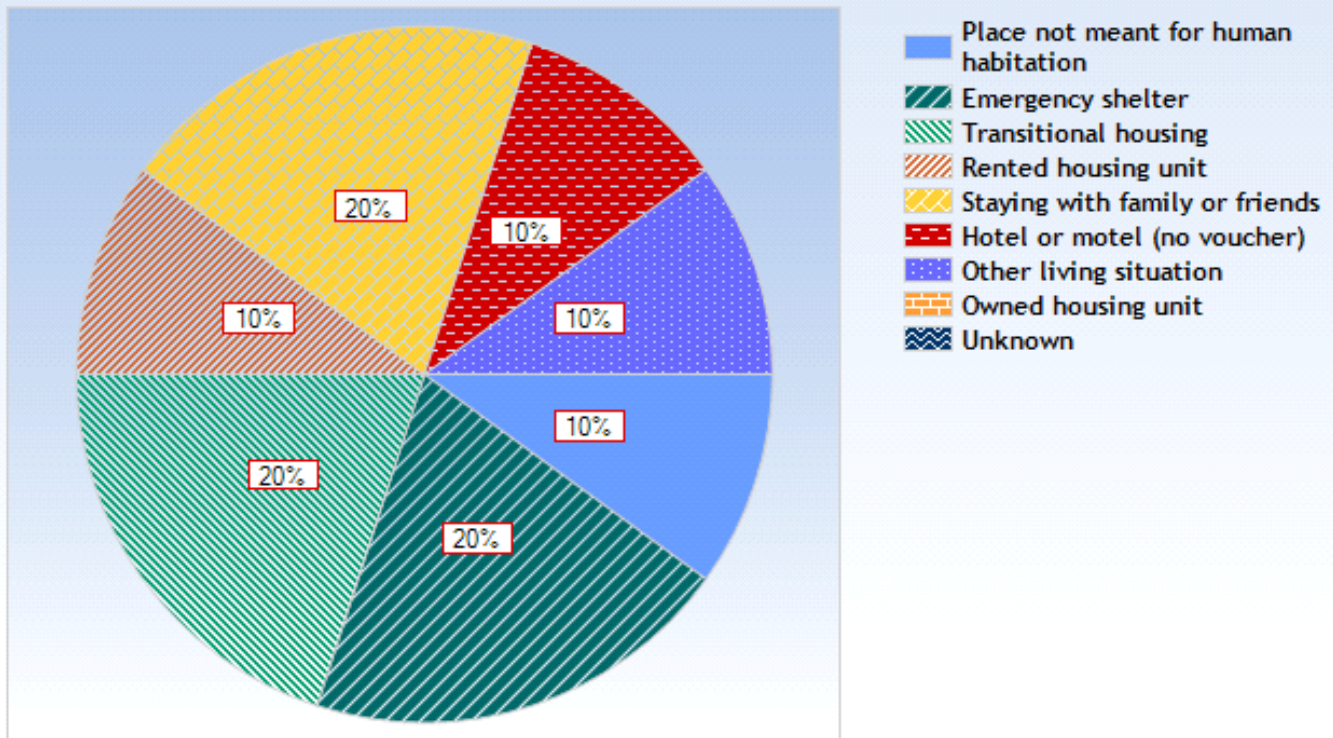
**Exhibit 4.4 Living Arrangement the Night before Program Entry: Veterans in Emergency Shelter**



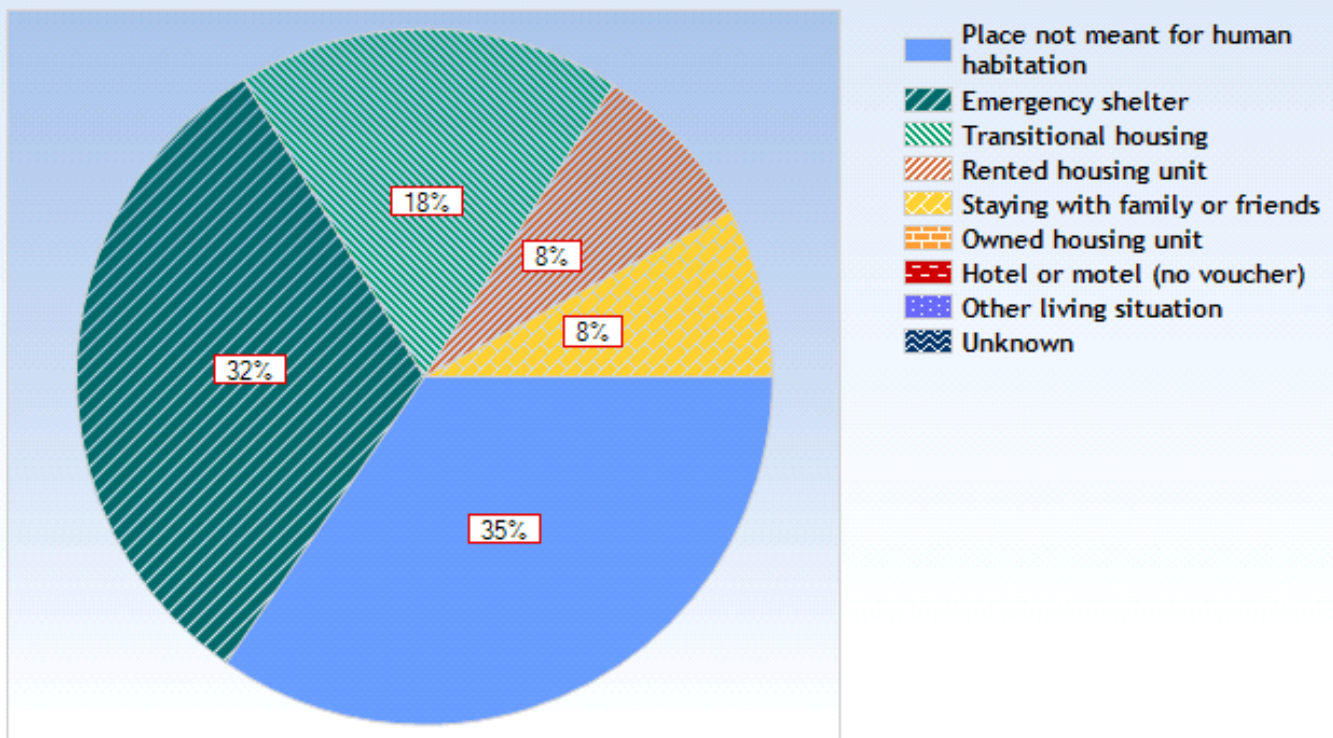
**Exhibit 4.5 Living Arrangement the Night before Program Entry: Veterans in Transitional Housing**



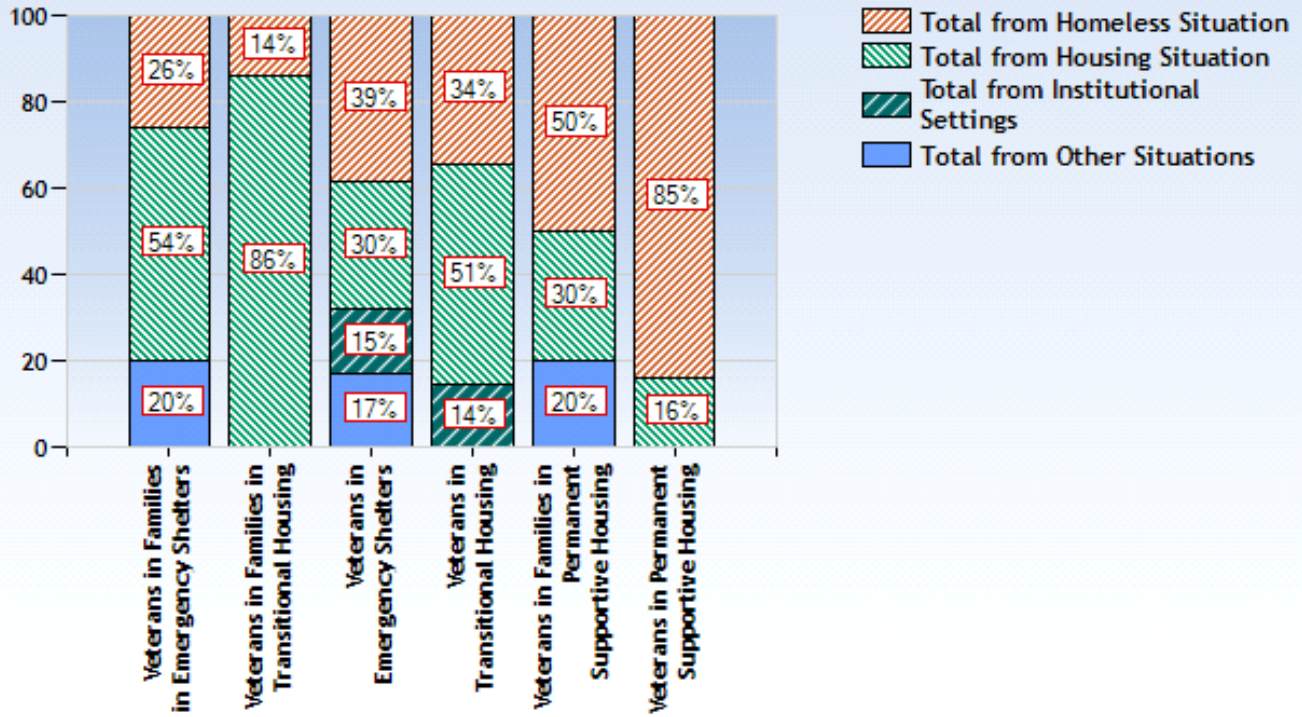
**Exhibit 4.6 Living Arrangement the Night before Program Entry: Veterans in Families in Permanent Supportive Housing**

**Exhibit 4.8 Prior Living Situation: Living Arrangement the Night Before Program Entry**



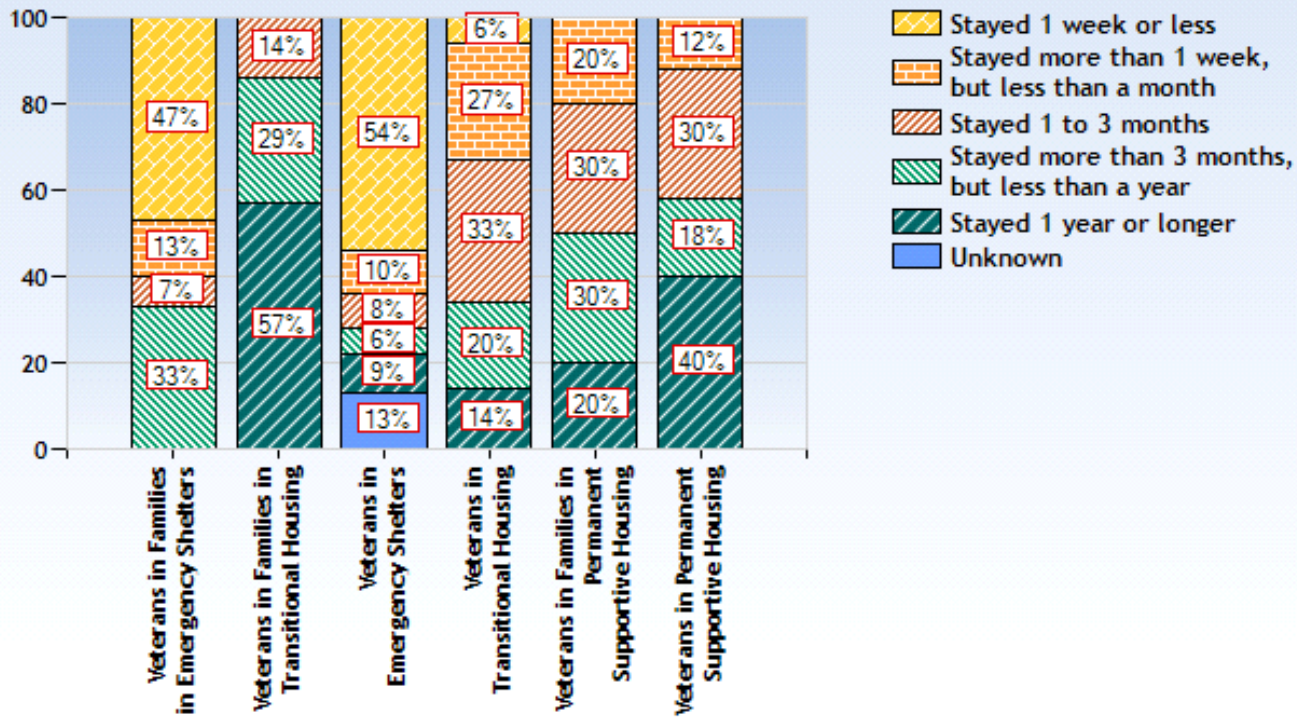

**Institutional Settings:** Psychiatric facility, Substance abuse treatment center or detox, hospital (non-psychiatric), Jail, prison or juvenile detention

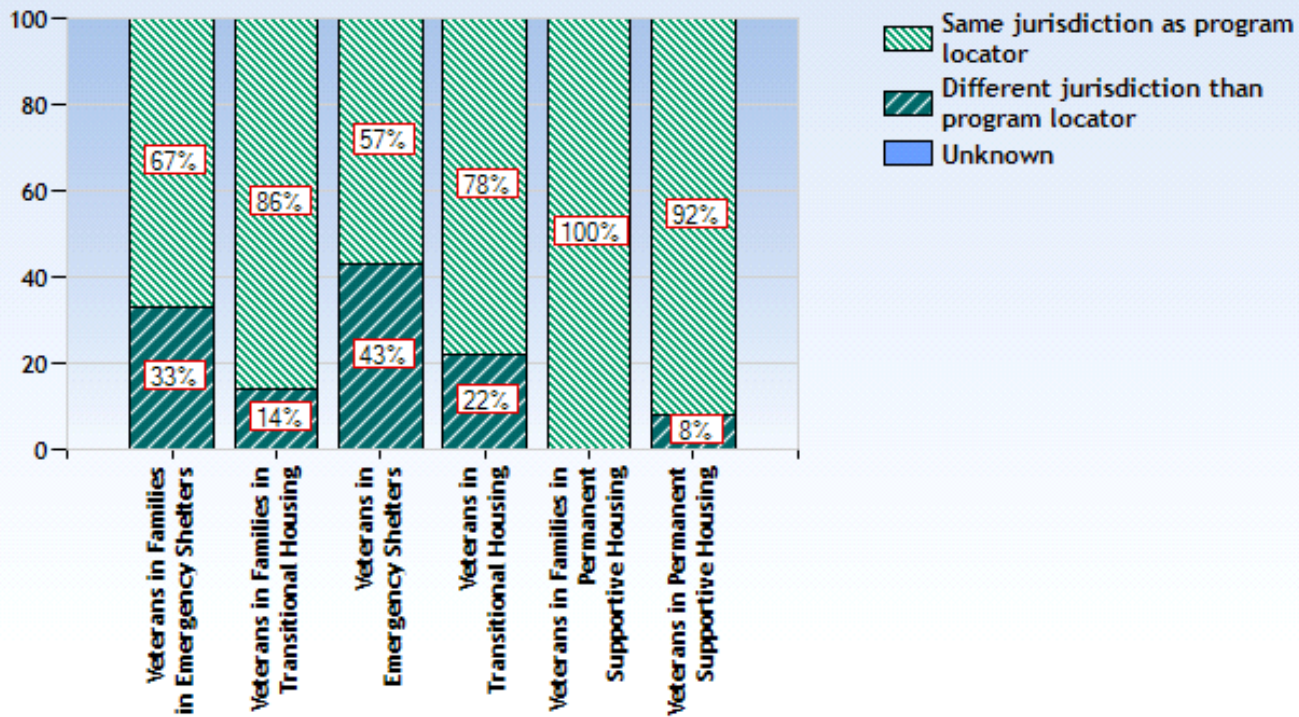
